Perfect Sounds reserves your event date upon receipt of a minimum \$500 deposit. Until receipt of the deposit, the date may be allocated to another client who has made a deposit (first-come, first-served). Kindly verify the information above and sign this contract. We accept local checks, money orders, and prefer Online payments. Cancellation of your event within 30 days of the agreed date incurs half the remaining balance billing; cancellation within 14 days results in full balance billing.

*In agreeing to the terms of this contract, the payer acknowledges the following arrangements agreed upon by both parties. Perfect Sounds and its DJ Music Entertainment staff members who are of legal age (21 and over), **will be treated as regular guests at the event**.
